**Member breakdown:**

- SMEs represent more than 1/3 of the total membership (c. 22% or 20 companies, was 4% in 2017))
- Large companies represent almost 2/3 of the total membership (64%, was 88% in 2017)
- Federations, associations or other organisations represent 14% of the total membership (or 13 entities, was 8% in 2017)
- 12 BRT members are female (13%, was 0% in 2017)
- Almost 2/3 of members are on the BRT's EU-side (64%), almost 1/3 are on the BRT's Japan-side
