TAX SYSTEM OF UKRAINE

CORPORATE TAXES

- Income tax – 18%
- Financial institutions – 25%
- Banks (2024) – 50%
- VAT (standard) – 20%

INDIVIDUAL TAXES

- Income tax – 18%
- Military tax – 1,5%
- Repatriation tax – 15%
- Unified Social Contribution (USC) (employer) – 22%

IT SECTOR DIIA CITY

- Special regime – 9%
- Employee personal income tax (PIT) – 5%
- Alternative to corporate income tax (CIT) – 18%

SIMPLIFIED SYSTEM

- Small businesses (groups 1-2) – 3%
- Medium-sized business (group 3) – 5%
- VAT (simplified tax system) – 0%
