European industry organizations' position & opinion concerning CEP



Field Survey: Circular Economy Package (CEP) in Europe

 MRI interviewed 6 European industry organizations listed below in the course of field work in Brussels, Belgium as a government project commissioned by Japan's Ministry of Economy, Trade and Industry (METI). The interviews took place between December 7 to December 10, 2015 to explore how the organizations view (analyze) the Circular Economy Package.

Organization	Brief Description
Industrial Minerals Association (IMA)-Europe	IMA-Europe is an umbrella organization which brings together ten European associations specific to individual minerals.
European Organization for Packaging and the Environment (EUROPEN)	EUROPEN is an industry organization presenting the opinion of the packaging supply chain in Europe on topics related to packaging and the environment, without favouring any specific packaging material or system.
EUROCHAMBRES	EUROCHAMBRES is the association of European chambers of commerce and industry.
FEBEM-FEGE	FEBEM-FEGE is a waste management industry association, which is a member of the European Federation of Waste Management and Environmental Services (FEAD)
European Recycling Industries' Confederation (EuRIC)	EuRIC is the umbrella organization for European recycling industries.
European Association of Metals (Eurometaux)	Eurometaux is the association which represents the European non-ferrous metals industry.

Summary of Findings 1/2

The study found that Manufacturers and SMEs tend to call for voluntary approaches, whereas recycling and waste process companies tend to call for ensuring effectiveness of policies and further incentives.

- a. Position and opinion concerning the CEP
 - 1. Agree CEP concept basically
 - 2. Acknowledge there are some issues on CEP effectiveness
 - 3. Express concern about stricter regulations (primary resource manufacturers, product manufacturers and SMEs)
 - 4. Call for voluntary policies based on market (primary resource manufacturers, product manufacturers and SMEs)
 - 5. Welcome product design approach (recycling and waste process companies)
 - 6. Watch next move over quality standards for secondary materials as well as End-of -Waste (EoW) criteria (recycling and waste process companies)
- b. Possible job creation and increasing competitiveness
 - 1. Acknowledge that efforts of CEP will create new business opportunities such as sharing economy (each organization)
 - 2. Indicate job creation in the recycling industry but not other industries
- c. Policy direction for product manufacturing and consumption
 - 1. Wait for details of Ecodesign Working Plan (2015 2017)
 - 2. <u>Point out that cooperation between manufacturers and recyclers is crucial for recyclability</u>
 - 3. Recognize pilot project of Product Environmental Footprint (PEF) as a voluntary approach
 - 4. <u>Indicate that PEF is too complicated as a communication tool to all customers</u>

Summary of Findings 2/2

- d. Efforts to be taken by businesses
 - 1. Have a high recognition that dialogue with stakeholders of value chain is beneficial and will be important .
- e. Considerations regarding waste management & secondary raw materials (SRM)
 - 1. Point out that the term, secondary raw materials, does not have a clear definition
 - 2. Have a view that there are different need according to value chain
 - 3. <u>Acknowledge that even EoW contributes to promotion of recycling, but point out that quality management for recycling is important</u>
 - 4. Point out that there is a need for incentives including tax break and public procurement to create the SRM market
 - 5. Appreciate that revised legislative proposal on waste clarifies definition of recycling rate as well as its calculation method
 - 6. Point out that there are challenges in implementing the revised legislative proposal on waste
 - 7. Point out that it is difficult to collect/provide data concerning chemicals management in terms of recycling and waste management
- f. Material security in CEP
 - 1. Wait for the European Commission's proposition on how to ensure critical materials
 - 2. Acknowledge that measures for materials which are difficult to procure from non-EU countries are essential

Product design	Ecodesign promotion	 EUROPEN does not get involved in the mandatory requirements since the scope of the Ecodesign Directive includes energy using products (EuPs) as well as energy related products (ErPs). As for plastics, light weighting has more economic advantage /incentives rather than recycling (different from metals). While recyclability is placed an emphasis in this discussion, recyclability is only one topic and should not be always focused on.

• EUROCHAMBRES is the association of European chambers of commerce and industry, which represents over 20 million businesses in Europe. More than 93% of these businesses are small and medium sized enterprises (SMEs)

Product design	Ecodesign promotion	 Although the requirements applicable are energy-related under the current Ecodesign Directive, if the scope of the Directive extends to recyclability, durability and reparability of the products, SMEs will have a hard time to deal with it.
Production process	Best practice promotion	 As for industrial symbiosis, participation of big businesses will have an impact. Although SMEs will benefit from it, the large corporation's initiative is still needed.
Consumption	Reliable information (fair business practice)	 EUROCHAMBRES agrees the PEF if participation of the measure is <u>on a voluntary basis</u>. There is concern that all value chain analysis done by large corporations may call for SMEs' involvement.
	Green public procurement (GPP)	 The association is skeptical about the green procurement. Setting mandatory requirements for <u>public procurement could</u> <u>lead to market distortion</u>. However, to make information provision mandatory is fine.

Product design	Ecodesign promotion	 Even if FEBEM-FEGE has been working on promotion of recyclability, it should be reminded that it does not make sense if used products/wastes can not be collected. Logistics for separate collection of waste are also essential. More awareness at design phase needs to be raised.
Production process	Best practice promotion	 Multiple industrial symbiosis projects are being implemented. In the most cases, involvement of a third party who connects waste treatment companies and manufacturers can be seen.
	Reliable information (fair business practice)	 While the idea of PEF and other initiatives are fine, member states' governments need to decide on which issue will be put their priorities on.
	Green public procurement (GPP)	 GPP scheme should be utilized in order to increase the use of SRM.

Recyclable materials	Quality standards for secondary raw materials (SRM)	 Quality, quantity and price are key to create a market for secondary raw materials.
