Introduction

Dear reader,

The EU-Japan Centre's key role in promoting European industry in Japan is evidenced by the results for fiscal year 2023, the first normal post-COVID year. In this unique market, we have informed, trained, and connected European businesses with Japanese customers through multiple activities throughout the year, including:

- Organising 4 physical business missions to Japan, bringing EU SMEs and clusters to trade fairs.
- Conducting 2 World Class Manufacturing sessions with 49 managers in Aichi Prefecture.
- Hosting 14 European SME managers in our Get Ready for Japan training programme.
- Arranging industrial internships for 16 European students in Japan and 22 Japanese students in Europe.
- Holding 10 market workshops across Europe with over 400 participants.
- Hosting 11 policy events, attracting over 4,400 participants.
- Responding to hundreds of inquiries from SMEs via the Centre's various helpdesks.
- Organising the 25th EU-Japan Business Round Table meeting in Brussels.

One disappointment to note is the unusually low number of partnership agreements between European and Japanese companies supported by the Centre. Several factors could explain this result: the lag time impact of the COVID period, the further weakening of the yen versus the euro, and technical issues affecting the promotion of company profiles on the Enterprise Europe Network Portal.

This also highlights the limitations of focusing solely on quantitative results. On average, it takes two years for a European SME to sign a business cooperation agreement with a Japanese company. This process involves numerous contacts, both physical and online, the exchange of detailed information, and the development of trust and relationships that, if successful, will last much longer than the negotiation period.

Japan, although a mature market, remains attractive for foreign companies. It offers access to major global corporations, key commercial partners with a strong presence in Asia, and is the EU's closest partner in the Indo-Pacific region. The country is also increasingly looking to attract startups from around the world to spur innovation and growth.

There is significant potential for European SMEs and startups in Japan. With its 37 years of experience, the EU-Japan Centre is your privileged partner to help you enter this demanding but rewarding market.

TRAINING

GRFJ – **Get Ready for Japan**

The 2-week **Get Ready for Japan** scheme offers EU managers a unique opportunity to experience and understand both the cultural and economic elements which define and explain Japan's business and technological achievements.

This flagship training programme sent **14 SMEs** to Japan in FY2023 (and a total of 752 companies since its creation in 1987).





Market access workshops

Co-organised with EEN local partners, the **market access workshops** help EU companies to access the **Japanese market** and help address topics related to **export & import procedures** as well as **cross-cultural practices**.



World Class Manufacturing (WCM)

The 5-day training course consists of **lectures**, **workshops and visits** to some of the world's most advanced Japanese factories in order to understand the real "Gemba" (production site), talk directly with their production managers and observe the effective implementation of manufacturing methods. This course gives its participants a detailed understanding of current Japanese approaches that they can adapt to help their companies' lean journeys. **Two physical WCM missions to Japan** were organised, welcoming **49 participants**.

Lean activities in Europe, showcasing how EU firms use Japanese production principles.



The EEN helps EU businesses **innovate and grow** on an international scale. It is the world's largest **support network** for small and medium-sized enterprises (SMEs) with international ambitions. The Centre serves as the contact point for EEN in Japan.

Business Missions

Matchmaking missions to Japan for EU Clusters and SMEs.

- Four 5-day missions for European Clusters and SMEs, enabling a total of 35 companies or clusters to exhibit in Japan.
- Four sectors represented:
 Biotech, Digital, Nanotech and Green Transition.
- Four pitching sessions or B2B events organised for mission participants.

EU-Japan Business Round Table (BRT)

The **Business Round Table** fosters **communication** between Japanese and EU industries; submits **recommendations** to the EU and Japanese Authorities.

The BRT's hybrid 25th annual meeting took place in the European Commission's Berlaymont HQ on 7 November 2023 and addressed "Economic Security & Supply Chains", "Green Transition", "Standardisation & regulatory harmonisation, R&D and skills" and "Digital & AI". During the meeting which was entitled, "The EU & Japan – Partnering on Economic Security for Sustainable Growth", the BRT members also had exchanges with senior representatives of the EU and Japanese Authorities. 39 of the 68 recommendations adopted by the meeting were joint recommendations from both sides of the BRT that were addressed to both the EU and Japan.

The BRT's 2023 recommendations were hand-delivered to **Věra Jourová**, Vice President, European Commission during the meeting, to the METI and MOFA Ministers and to the MIC State Minister on 22 & 23 January 2024 and to **Prime Minister Kishida** on 16 February 2024.





Horizon Europe National Contact Point

Promotes **research cooperation** and **supports participation** by Japanese organisations. This activity is financed by METI.



Space.Japan

Space.Japan is a project created by the EU-Japan Centre for Industrial Cooperation to support cooperation in **Space-related industries** both upstream and downstream, as well as in **Space applications and utilisations industries**, with a focus on certain sectors such as Space Communications, Earth Observation (EO) and Global Navigation Satellite Systems (GNSS).

- Developed **13 leads** which could create partnerships between EU and Japan space entities
- Organised **4 pitching webinars**, **1 virtual mission** to ISIEX Tokyo 2024 (20-22 February 2024), and co-organised **1 webinar** with the European Innovation Council (EIC) and **1 hybrid event** with the SEE Lab of Bocconi University in Milan
- Handled **12 inquiries** from European and Japanese space companies and stakeholders
- Engaged in communication through social media (Twitter/X), receiving a total of **5,797 impressions**
- Held meetings with organisations/companies in Japan related to the Space sector on **11 occasions**
- Recorded **1 Advisory Achievement** in the Enterprise Europe Network Japan for the introduction made between a client (GReD) and a law firm that enabled the client to fine-tune its internationalisation strategy for the Japanese market

Regional & Cluster Cooperation Helpdesk (EJR2C)

Regional cooperation platform mobilising European regions and clusters, Japanese Prefectures and clusters through the **EU-Japan Economic Partnership Agreement** (EPA), and the **EU-Japan Partnership on Sustainable Connectivity**. The EJR2C Helpdesk promotes cooperation in terms of industry, trade, investment, innovation, tourism, and the mobility of people.



The online "EU-Japan Regional Cooperation Annual Conference & Matchmaking" event was held on 16 and 17 January 2024 with 44 participants. "Trends of EU-Japan Regional Cooperation" was the theme of the event.

EU CLUSTER MANAGER MOBILITY TO JAPAN

A short-term mobility programme in Japan for EU Industry Cluster Managers with the goals of **supporting international cooperation** between industry clusters in the EU and their counterparts in Japan and **promoting the internationalisation** of EU cluster-hosted SMEs and EU-Japan business, as well as **fostering future technology and innovation partnerships**.
